### Reservation Terms and Conditions

- 1) Credit card required for reservation.
- 2) Ecoquest requires 24 hours notice prior to scheduled departure time to cancel your reservation or to change the number of participants in your group. Cancellations with more than 24 hours notice will not be charged. Cancellations with less than 24 hours notice will be charged the full amount.
- 3) For your safety, Ecoquest reserves the right to cancel any activity due to adverse weather conditions. If this happens, you will not be charged for the activity.
- 4) Ecoquest and its represented guides have the right to cancel the activity at any time in the event of disorderly conduct, drug or alcohol use, or any other participant behavior which threatens the safety of the group. In this case the person(s) whose behavior is deemed responsible will be charged the full amount of the activity.
- 5) Ecoquest requires good health and physical condition. Participants will be travelling on uneven and slippery terrain, wading in moving water, standing near steep ledges and cliffs, hiking over sustained hills and kayaking. If you have a medical or physical condition which makes participating in these activities dangerous for you, you should not participate. Due to size restrictions on our harnesses and other technical equipment, we're not able to accommodate people weighing over 250 pounds on rappelling or zip-lining elements at our tours. Ecoquest reserves the right to cancel or limit your participation based on your physical condition. If you have any questions or concerns about your ability to participate safely, speak with our staff ahead of time. If you have to cancel your participation at the last minute due to an undisclosed medical or physical condition you will be responsible to pay the full amount of your trip.
